CROO Seed-to-Sale Newsletter – End of Year Message

For latest updates on the state's conversion to Metrc seed-to-sale

BIOTRACK USE ENDING FOR STATE:

- ✓ The State will end its contract with BioTrack in February 2026.
- ✓ If you need annual reports from BioTrack, **pull them before 2/1/2026!**
- ✓ If you use BioTrack as your inventory management system, our contract will not impact your system. Check with BioTrack for more information on your impact.

MEDICAL CANNABIS PATIENTS:

- ✓ ***Watch for misconfigured items with incorrect weights*** → if the incorrect weight was added in Metrc, it could be limiting medical patients' purchases.
- ✓ ***Help us correct wrong data*** → please use [Metrc's bulletin](#) and Metrc Support to identify and correct any mistakes before the affect medical patients' allotments.
- ✓ ***Stay tuned!*** Metrc will soon share remaining allotment with the Patient Portal.

IN-STATE / OUT-OF-STATE PURCHASES:

- ✓ ***Tracking of residency status for adult use purchases*** → just as in BioTrack, Illinois requires reporting adult use sales as either to in-state or out-of-state consumers.

COMING SOON:

- ✓ ***Metrc Expert*** → Metrc will soon be launching an AI-powered chatbot to answer how-to questions and direct you to additional support. Metrc Support and customer services will still be available!
