J: Illinois Resident Controlled or Owned	n/a	410 ILCS 705/1-10 – definitions of “primary residence”, “resided” 410 ILCS 705/30-15(a)(10) 8 IAC 1300.307(a)(10) A person may demonstrate residency in the State of Illinois by providing for each of the past 5 years either: (1) Tax records for each of the past 5 years - a copy of pages 1 and 2 of the person’s IL-1040 tax return with page 2 signed by the person, OR (2) Two or more of the following for each of the past 5 years: a signed lease agreement that includes the applicant's name; property deed that includes the applicant's name; school records; voter registration card; an Illinois driver's license, an Illinois Identification Card, or an Illinois Person with a Disability Identification Card; a paycheck stub; or a utility bill. A person may submit a combination of tax returns and other documentation identified above, but must provide sufficient documentation for each of the past five years. For example, a person may choose to submit tax forms for 2017 and 2019, and two forms of other documentation for years 2015, 2016, and 2018.
